

PROMOTION OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN.

OPEN ONLY TO LEGAL RESIDENTS OF THE 50 UNITED STATES AND DISTRICT OF COLUMBIA, 18 YEARS OF AGE OR OVER. INTERNET ACCESS REQUIRED.

- 1. Promotion Period:** The Unilever + Today's Dietitian Webinar Sweepstakes (the "**Promotion**") begins June 1, 2016 at 12:00 a.m. Eastern Time ("**ET**") and ends June 27, 2016 at 2:59 p.m. ET (the "**Promotion Period**").
- 2. Eligibility:** Open to legal residents of the 50 United States and the District of Columbia, 18 years of age or older as of date of entry. Employees of Conopco, Inc., d/b/a Unilever (the "**Sponsor**"), Don Jagoda Associates, Inc. Sponsor reserves the right to cancel, terminate or modify the Promotion if it cannot be completed as planned for any reason, including infection by computer virus, bugs, tampering, unauthorized intervention, technical failures or corruption of any sort.
